# RESOLUTION APPROVING THE "COVINGTON MILL, LAKE FOREST ESTATES, LONG CANYON, RIDGEVILLE" ANNEXATION TO TRINITY CENTER COMMUNITY SERVICES DISTRICT (File # LAF-10-03)

The following Resolution is now offered and read:

WHEREAS, a proposal for the annexation of certain territory to the Trinity Center Community Services District in the County of Trinity has been filed with the Executive Officer of this Commission pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and

**WHEREAS**, the proposal is for the annexation of approximately 14,260 acres, resulting in a total district size of approximately 20,200 acres; and

WHEREAS, the Executive Officer has reviewed the proposal and prepared a report, including his recommendation thereon, the proposal and report having been presented to and considered by this Commission; and
