1. Chairman McHugh called the meeting to order at 6:40pm
2. Approval of the Past Minutes

Minutes were presented from the 12/4/12 regular meeting. Director Ahmann noted a change for the minutes:

- FY12 MD&A and Audit Results: Director Ahmann presented the reports. The end of year was June 30, 2012. The County just closed their books.

There are minor differences between the reports due to the timing of the data sent to the auditor. Property tax comes in the second half of each year. The TC VFD is now included in the audit.

The Management Discussion reflects that 2011-2012 was a good year with revenue greater than expenses. Director Ahmann will submit the Discussion to the Auditor.

The approval of the final audit and MD&A will be added to the February CSD meeting agenda. Feedback from Directors is needed by Wed Jan 9.

- Approval to pay the auditor's invoice: The invoice is for \$1,875

Director Ahmann motioned to approve payment of the auditor invoice. With a second from Director Rusnak, the motion passed.
